<p>Description: This is a combined preliminary hearing of two appeals, appeal 16-0027 and appeal 16-0028. For administrative purposes, the combined appeals have been assigned the number of appeal 16-0030A.</p> <p>Appeal 16-0027 concerns the refusal of Surface Material Lease application 150030 made by Dwayne Thiessen of Sigga Oilfield Services Ltd. ("the Appellant"). The Appellant alleges that the Director erred in the determination of a material fact on the face of the record, erred in law, did not comply with a regional plan approved under the <i>Alberta Land Stewardship Act</i>, and under section 15 of the Public Lands Administration Regulation, the Director was untimely in making a decision, resulting in a deemed rejection.</p>	

Appeal 16-0028 concerns the refusal of Surface Material Lease application 150035 made by 1447537 Alberta Ltd. ("the Appellant"). The Appellant alleges that the Director erred in law, did not comply with a regional plan approved under the *Alberta Land Stewardship Act*, and under section 15 of the Public Lands Administration Regulation, the Director was untimely in making a decision, resulting in a deemed rejection.
